 - (vii) Two members of the Central Council to be Delhi University Students' Union.

DISQUALIFICATION FOR OFFICE BEARERS:

1. No member of the Union shall be entitled to hold any post of the Office-bearer, if
 - (i) She/He has exceeded the age of 22 years on 16th August of the year in which he wishes to seek election; or
 - (ii) She/He completed more than 7 years from the 1st July of the calendar year of passing 10+2 examination; or
 - (iii) She/He has been convicted of a criminal offence including moral turpitude, or She/He has been punished by the University/College for an act which is coercive in nature and constitutes a threat to life and property; or
 - (iv) She/He has been found guilty of and punished for the use of unfair means in any Examination of University or Board; or
 - (v) She/He has not clearly passed the previous University Examination.
2. No elected office-bearer shall be entitled to hold the same office twice.

If at any time now or later it is found out that he/she is guilty of the above charges, he/she is liable to be disqualified for any of the reasons above and that his/her candidates even after election shall be cancelled. The decision of the Election Officer shall be final in this regard.

4. For Girls' Common Room Secretary, the Candidate's Proposer and Secunder should girl students only.
5. For Boys Common Room Secretary, the Proposer and Secunder should be boy students only.
6. (a) The names of the Candidates, Proposers and Seconders should be the same as in the College record.

(b) Any error/discrepancy in the Identity Card should be brought to the notice of **Shri Baru Singh** in the College Office **immediately**.
7. The Scrutiny Officer should write on each nomination from 'VALID' or 'INVALID' as the case may be and should put their signatures on each nomination form.
8. The list of candidates for each Office/Post whose nominations are found in order, should be prepared separately.
