Application for College Fee Concession for Needy Students for the academic year 2019-2020

Full or partial fee concessions (against specific heads of college fees) may be available to students whose parent's / guardian's annual income fall under a limit specified below.

Such students who are desirous of availing the fee concession may apply to the college, in prescribed application form (available at the college office) along with copies of all relevant documents, latest by 21^{st} November 2019.

The forms will be available in the college office (**Ms Asmita**, **Window No. 7**) from 25th October 2019 and the same can also be downloaded from the College website **www.kmcollege.ac.in.**

Eligibility Criterion for Application:

For General Students:

Students, whose parent's/guardian's combined gross annual income from all sources does not exceed Rs. 3,00,000 per annum.

For SC/ST/OBC Students:

Students, whose parent's/guardian's combined gross annual income from all sources does not exceed Rs 4,00,000 per annum.

Applicants are required to submit attested copy of income certificate or affidavit (signed by parent/guardian) disclosing the gross annual income for the current financial year 01.04.2018 to 31.03.2019 at the time of interview.

NOTE:

The decision to allow fee concession and the extent of it (full/half/partial) for each individual applicant will be made by the Fee Concession Committee of the college. The committee's decision will be final regarding this matter. The committee may call the applicants for an interview on a notified date and ask for any additional information or documents.

The fee concession will not cover any part of the fees to be paid to the University. Incomplete applications or applications without the income certificate (or affidavit) and other relevant documents will not be considered. Any student found guilty of submitting false proof of income will face strict disciplinary action. Bank account in the name of applicant is mandatory.
